Arie Eernisse FCIArb is a senior foreign attorney at Peter & Kim and has been practicing international arbitration in Asia for the past decade.

The subject matter of his cases spans a diverse array of industry sectors and topics, including construction, distribution agreements, energy, finance, insurance, intellectual property, maritime, mergers & acquisitions, military procurement, pharmaceutical, product liability, sale of goods, and services, among others.
